



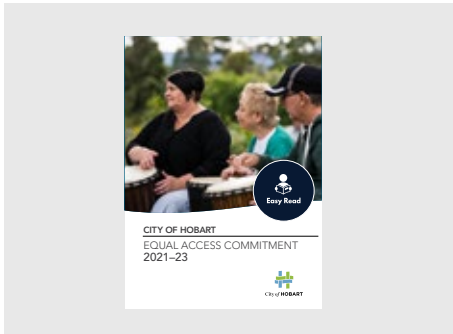

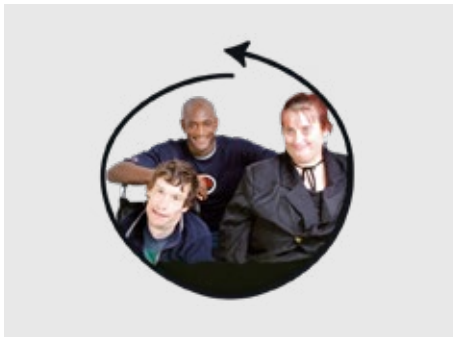

About this report



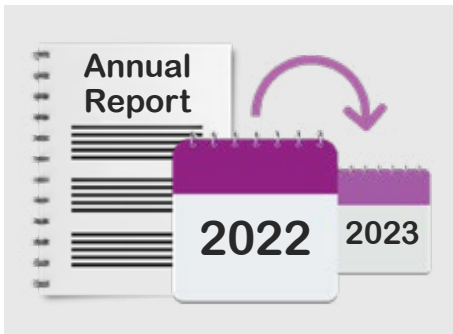
City of Hobart wrote the **Equal Access Commitment**.

We will say **EAC** for short.



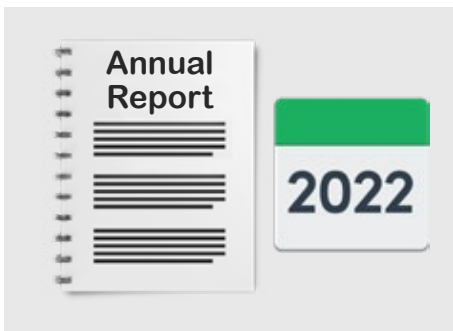
The **EAC** is about how we will make sure Hobart is **inclusive** for everyone.

Inclusive means everyone can join in.



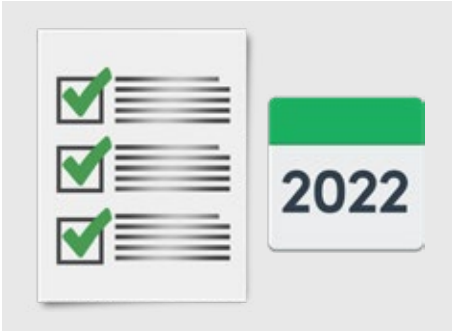
Every year we write a report about how we are going with the EAC.

We had the **Ability to Create** art show in July 2022.

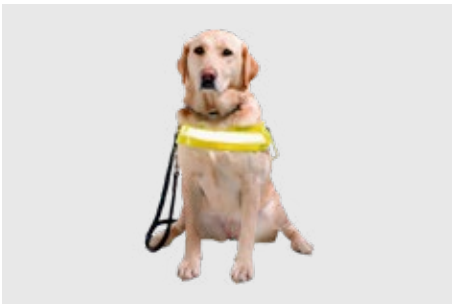


There were lots of artists and people who came to see it.

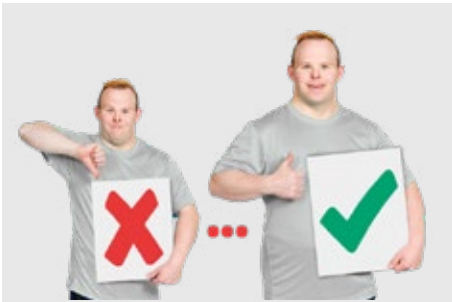


We helped to have inclusive

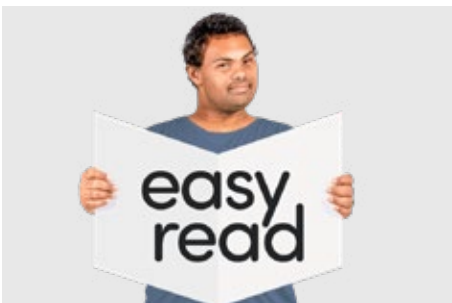
- Sports days

This will help make sure more people can be part of them.



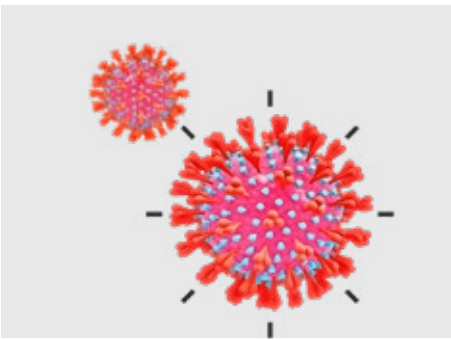
We did training about how to give good support to people with disability for staff from

- Our staff.

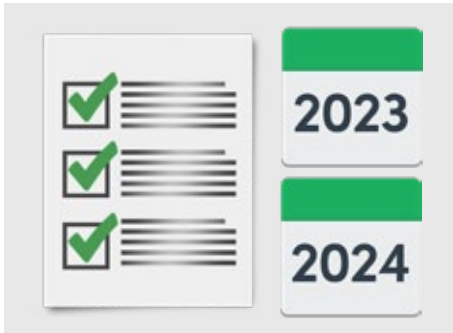


Some things we wanted to do for the EAC took longer because of the changes.

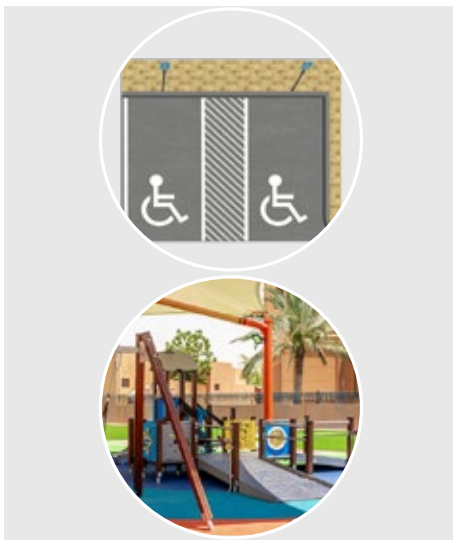


Big things like new buildings or changes to streets will also take longer.

What we will do next

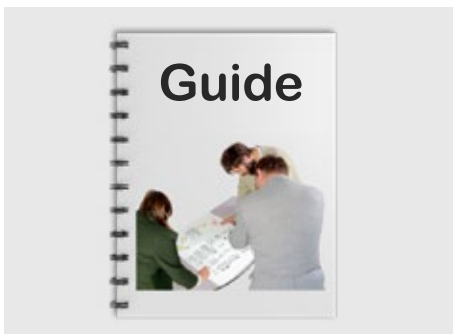


These are the things we will do this year and next year.

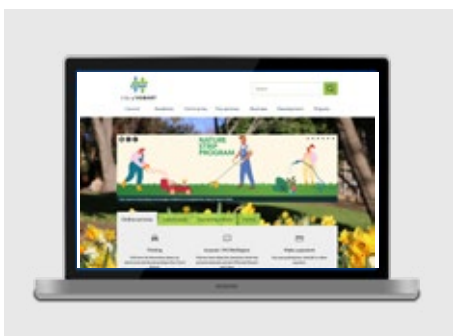


We will make City of Hobart parks better with

We will put on our website how we are going with the EAC.



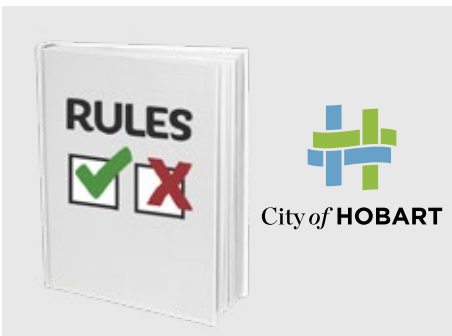
We will make the **City Mobility Map** easier to use online.



The **City Mobility Map** helps people with disability get around Hobart.



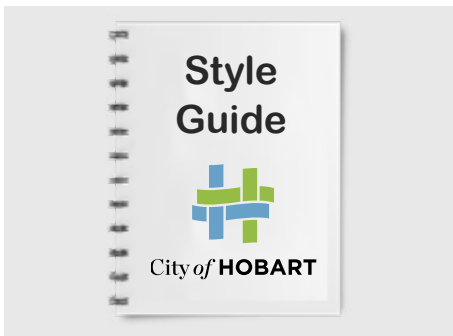
We will have rules for how to make events and other things inclusive.

- People from Government.

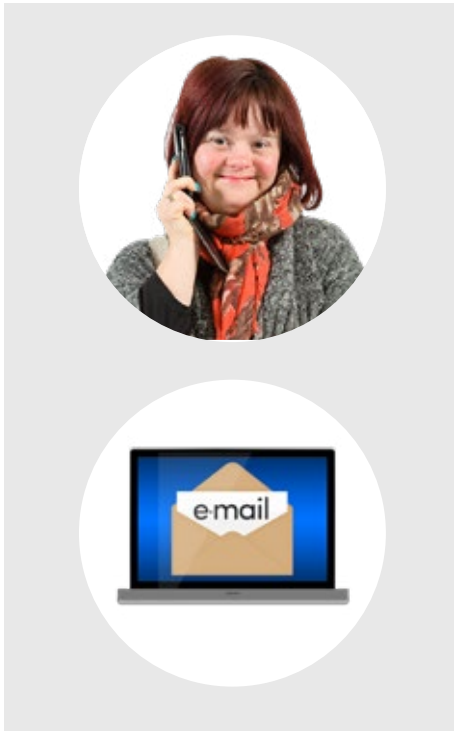


We will keep going with the **Hobart Respects All** campaign.
